

## **BBYO's International Convention 2011 Free Flight Contest**

***NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.***

### **1. HOW TO ENTER**

- a. The International Convention 2011 Free Flight Contest will begin on Thursday, August 19, 2010 and end on Thursday, September 2, 2010 at 11:59pm Eastern.
- b. To participate in the contest, you may enter via the following method:

Register for International Convention 2011 at [b-linked.org](http://b-linked.org). Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an Internet access provider, online service provider or other organization that is responsible by assigning email address or the domain associated with the submitted email address.

- c. BBYO is not responsible for entries not received due to difficulty accessing the Internet, service outage or delays, computer difficulties or other technological glitches.

### **2. ELIGIBILITY RESTRICTIONS**

- a. The contest is open to BBYO members from age 13 until they graduate from high school. Employees of BBYO, its affiliates, its sponsors/promotional partners, are ineligible to participate or win.
- b. Three prizes only will be awarded to any authorized registrant of International Convention 2011 by Thursday, September 2, 2010 at 11:59pm Eastern.
- c. Contestants are required to provide truthful information and BBYO will reject and delete any entry that it discovers to be false or fraudulent. BBYO will disqualify any entry from individuals who do not meet the eligibility requirements, and BBYO will also delete any entry received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

### **3. PRIZES**

- a. The following prizes will be awarded:

Three winners will be selected at random to receive free flights to International Convention 2011.

BBYO, Inc. is responsible for the booking of the tickets and pre-approving the selections made by the winners. The flights shall reflect travel for the winners from his/her home destination to Los Angeles International Airport (LAX) from February 17-21, 2011.

BBYO is not responsible for providing chaperones on flights where minors will travel alone. Flights will be booked by BBYO, Inc. no later than September 30, 2010.

- b. The winner will be notified by a representative from BBYO's International Office no later than September 3, 2010.
- c. There is no substitution, transfer, or cash equivalent for prizes. The prize is expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of BBYO management with respect to the contest are final.
- b. Three winners will be chosen in September 2009.
- c. The odds of winning depend upon the number of entries received, as applicable.
- d. The winner will be contacted by e-mail. The winner must respond to BBYO in writing within one week to accept any prize and authorize the mailing of such prize as specified in Section 3(b) above. If winner does not respond within such time, prize will be forfeited and an alternate winner may be chosen.

#### 5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winners. Winners may be required to sign an IRS Form W-9 or the equivalent.
- b. By participating in the contest, the winner or winners agree to have their name, voice, or likeness used in any advertising or marketing material relating to this contest without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize or prize certificate, BBYO in its sole discretion may require contest winners to sign a liability release, agreeing to hold BBYO, its affiliated entities, and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the contest.
- d. BBYO, in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of BBYO's Web Site or is otherwise in violation of the rules.
